

Ordinance No. 763

**AN ORDINANCE AMENDING A PORTION OF THE MUNICIPAL CODE
RELATING TO PARKING SCHEDULES**

WHEREAS, the Ordinance and Claims Committee, at public meeting on October 22, 2013, at City Hall, discussed and recommended that the Common Council adopt an ordinance amending parts of the City's parking schedules as contained in Chapter 74 of the Municipal Code; and

WHEREAS, the Common Council of the City of Mineral Point considered the Ordinance and Claims Committee's recommendations at its regularly scheduled meeting on November 5, 2013, at City Hall; and

WHEREAS, the Common Council determined that the recommendations of the Ordinance and Claims Committee will promote and safeguard public safety and welfare;

NOW THEREFORE, the Common Council of the City of Mineral Point does ordain that the Municipal Code of the City of Mineral Point be changed as follows:

Chapter 74 of the Municipal Code of the City of Mineral Point is hereby amended to add the following to Schedule I, Time-Limited Parking, and Schedule III, No Parking Areas, in proper alphabetical order:

CHAPTER 74: PARKING SCHEDULES		
SCHEDULE I. TIME-LIMITED PARKING		
Street/ Direction	Restriction	Max. Permitted Duration
Pleasant St. - South Side; commencing at a point 2190 ft west of Pleasant Street's intersection with Ross Street and continuing west to Peasant Street's intersection with Fair Street.	Any Day; Any Time	2 hrs

SCHEDULE III. NO PARKING AREAS

Street	Location	Restriction
Pleasant Street - South Side	Commencing at a point 1823 feet west of Pleasant Street's intersection with Ross Street and continuing west 367 feet, to the point of beginning of time-limited parking (See Schedule I. Time-Limited Parking.)	No parking at any time.
Pleasant Street - North Side	Commencing at a point 1823 feet west of Pleasant Street's intersection with Ross Street and continuing west to Pleasant Street's intersection with Fair Street.	No parking at any time.
Fair Street	Commencing at a point 1255 feet west of Fair Street's intersection with Ross Street and continuing west, then north, then northeast to Fair Street's intersection with Pleasant Street.	No parking at any time.

Adopted at the regular meeting of the Common Council of the City of Mineral Point, held on November 5, 2013, at City Hall, in the City of Mineral Point, Iowa County, Wisconsin.

This Ordinance shall be in full force and effect upon passage and publication as provided by law.
