The Regular meeting of the Common Council was held at the City Hall/Community Room on the above date and time.

The meeting was called to order by Mayor, Gregg Bennett @ 6:00 p.m. Roll call and Alderpersons present: Basting, Schmit, Clark, Rash, Oellerich, Mitchell, Pittz and Galle. Clerk Treasurer Heisner and Attorney Pfotenhauer were also present.

A motion was made by Ald. Basting, seconded by Ald. Mitchell, to accept the minutes of the October Council Meeting. All in favor – motion carried.

There was no public comment.

In Mayors Correspondence he congratulated Andy Palzkill and the Football team for a great season. He also congratulated Eric Heisner, Debi's son for his honors and accomplishments. He congratulated the Cross Country team for their great season. He also mentioned that Alliant will be line rebuilding on Water Street behind the Five-Point intersection. It will require some trees to be trimmed but none of the trees are on the City Tree list.

In Clerks Correspondence Clerk Heisner made mention of the tax roll process for this year. This process is when delinquent water bills are placed on tax bills. The amount for this year is approximately \$3600. Going to monthly billing and disconnections have brought this number down considerably over the past 7 years. The Fire Department is wondering about the Committee that was discussed a couple months ago in regard to purchasing the new fire truck. If anyone is interested this is the time to get on board as they are getting their quotes and pricing in for the truck. The City's mill rate is not yet determined. As soon as that information is available it will be sent out to council.

There was a motion by Ald. Basting and a second by Ald. Mitchell to go into Closed Session. Closed Session - Pursuant to Wis. Stats. Sec. 19.85 The closed session is in accordance with Wisconsin State Statute 19.85 (1) (c) considering employment, promotion, compensation, or performance evaluation data of any public employee over which the governmental body has jurisdiction or exercises responsibility. There was a motion by Ald. Mitchell and a second by Ald. Schmit to go back into regular session.

The Finance Committee presented 2 budget proposals. They recommended the budget transferring 2 employees' wages to the City hall budget. There was a motion by Ald. Schmit and a second by Ald. Clark to approve the 2018 Budget. Motion carried on a roll call vote.

There was a motion by Ald. Galle and a second by Ald. Basting to approve the following Ordinance for the ETZ RE-certification. Approving this ordinance and map will allow for the Farmland Preservation recipients to receive their credit for 2017. More updates to the map can be made up until December 2018. Motion carried on a roll call vote.

## ORDINANCE NUMBER \_787\_\_ EXTRATERRITORIAL ZONING ORDINANCE AMENDMENT

WHEREAS, the Common Council of the City of Mineral Point, by Ordinance Number 686, on December 6, 2005, adopted Chapter 155 [formerly Chapter 20] of the Municipal Code, entitled Extraterritorial Zoning; and WHEREAS, the City's ETZ Committee, after public hearing, voted to recommend certain amendments to the text and map of Chapter 155 to the Common Council for adoption; and

**WHEREAS,** having been presented with the ETZ Committee's recommendations, and after further public hearing regarding, and consideration of, the proposed amendments, the Common Council finds that the recommended amendments are in the best interests of the citizens of Mineral Point and landowners within the City's extraterritorial zoning jurisdiction;

**NOW, THEREFORE, BE IT ORDAINED** that the recommendations of the ETZ Committee regarding amendments to the text and map of Chapter 155, copies of which are attached hereto and incorporated herein by reference, are hereby adopted.

This Ordinance shall become effective upon publication.
